RESOLUTION NO. 52

"WHEREAS, due to inadvertence this Body failed to include in the current annual budget the position of Market Cleaner in Barrio Valencia; under "Market and Slaughterhouse", Office of the City Treasurer;

"WHEREAS, upon representations with the City Treasurer by Councilor Guillermo T. Parrilla, the ~~former~~ had manifested that said position can be placed under casual status and be paid on daily basis depending upon the number of Sundays; worked by the Market Cleaner at the rate of Four Pesos (P4.00) per day;

"WHEREAS, it becomes necessary that the foregoing omission be inserted in the budget in order to maintain efficiency in the public service;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Jesus B. Lladoc;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 3

AN ORDINANCE AMENDING ORDINANCE NO. 8 (1961-1962 CITY BUDGET),
CURRENT SERIES

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Section 1 of Ordinance No. 8, current series (1961-1962 City Budget), is hereby amended in the manner provided for hereunder as follows:

On page 6, under "MARKET", Office of the City Treasurer, the following position should be included:

One : Market Cleaner (Valencia) at P4.00 per Sunday

SECTION 2. EFFECTIVITY. This Ordinance shall take effect March 1, 1962.



"RESOLVE FINALLY, to furnish copy of this resolution each to the City Treasurer and the City Auditor, both of Ormoc City.




