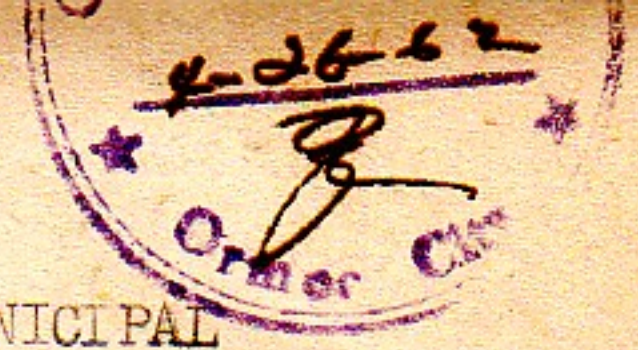

ORDINANCE NO. 5

AN ORDINANCE AMENDING RESOLUTION NO. 202, EMBODYING ORDINANCE NO. XV,  
APPROVED DECEMBER 11, 1956, ENTITLED "AN ORDINANCE REGULATING THE  
ESTABLISHMENT AND MAINTENANCE OF COCKPITS IN ORMOC CITY" BY DELET-  
ING THE FIGURE "P50" AND CHANGING IT TO "P40" IN PROVISION NO. 4 OF  
SUB-PARAGRAPH "(a)" UNDER SECTION 1 THEREOF AND FOR OTHER PURPOSES

BE IT ORDAINED by the Municipal Board of Ormoc City pursuant to the  
provisions of Republic Act 179 as amended by Republic Act 429, That:

SECTION 1. Resolution No. 202, series of 1956, embodying Ordinance No.  
XV, is hereby amended by deleting the figure "P50" and changing it to "P40"  
in Provision No. 4 of sub-paragraph "(a)" under Section 1 thereof, so as to  
read as follows:

"4. In all other barrios not herein specified, P40 per quarter."




"RESOLVED FINALLY, to furnish copy of this resolution each to all cock-

"CARRIED UNANIMOUSLY."


