ORDINANCE NO. 5

AN ORDINANCE AMENDING RESOLUTION NO. 202, EMBODYING ORDINANCE NO. XV, APPROVED DECEMBER 11, 1956, ENTITLED "AN ORDINANCE REGULATING THE ESTABLISHMENT AND MAINTENANCE OF COCKPITS IN ORMOC CITY" BY DELETING THE FIGURE "P50" AND CHANGING IT TO "P40" IN PROVISION NO. 4 OF SUB-PARAGRAPH "(a)" UNDER SECTION 1 THEREOF AND FOR OTHER PURPOSES

BE IT ORDAINED by the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, That:

SECTION 1. Resolution No. 202, series of 1956, embodying Ordinance No. XV, is hereby amended by deleting the figure "\$50" and changing it to "\$40" in Provision No. 4 of sub-paragraph "(a)" under Section 1 thereof, so as to read as follows:

"4. In all other barrios not herein specified, \$40 per quarter."
