RESOLUTION NO. 159

"WHEREAS, this Body, considering the volume of work handled by the Office of the City Attorney, sees the necessity of employing a Filing Clerk in said office;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 7

AN ORDINANCE CREATING THE POSITION OF FILING CLERK IN THE OFFICE OF THE CITY ATTORNEY AND PROVIDING FUNDS FOR SALARY THEREOF

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The position of Filing Clerk is hereby created in the Office of the City Attorney, Ormoc City, with compensation at the rate of One Thousand Two Hundred Pesos (P1,200.00) per annum.

SECTION 2. The sum of One Thousand Two Hundred Pesos (P1,200) is hereby obligated in the 1962-1963 City Budget to cover the salary of the position hereby created and, thereafter, corresponding appropriation shall be provided in succeeding city budgets.

SECTION 3. This ordinance takes effect July 1, 1962.
