RESOLUTION NO. 7

"WHEREAS, the City Treasurer, this City, in his letter dated January 10, 1963, has recommended to change the designation of the position of one (1) campaign clerk at P1260 per annum in the present plantilla of personnel in his office to the position of Property Clerk at P1680 per annum considering the importance of the functions of the latter which is actually performed by an incumbent;

"WHEREAS, the salary differential to cover the remaining six months of the fiscal year occasioned by this change of designation effective January 1, 1963, will entail an amount of P210 which the City Treasurer recommends to be appropriated from any funds otherwise unappropriated;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Abas;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 2

AN ORDINANCE AMENDING ORDINANCE NO. 11 (1962-1963 CITY BUDGET),
SERIES OF 1962

BE IT ORDAINED by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 479 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Section 1 of Ordinance No. 11 (1962-1963 City Budget), series of 1962, is hereby amended in the manner provided for hereunder as follows:

Under the Office of the City Treasurer, page 5, the following line should be deleted, to wit:

"One : Campaign Clerk P 1,260.00"

and in lieu thereof, the following should be provided:

"One : Property Clerk P 1,680.00"


SECTION 2. EFFECTIVITY. This ordinance shall take effect as of January 1, 1963.

"RESOLVED, FURTHER, that the sum of P210 covering the salary differential for the remaining six months of the fiscal year occasioned by this change of designation effective January 1, 1963, be appropriated from any fund not otherwise appropriated to carry out the provisions of this ordinance;



"CARRIED UNANIMOUSLY."


