## RESOLUTION NO. 8

"WHEREAS, the City Auditor, this City, in his letter dated today, has made representations regarding the setting aside of \$1,200.00 to cover the deficiency in the appropriation for the position of Senior Clerk in his office at the rate of \$2,400.00 per annum effective July 1, 1962, instead of January 1, 1963, as appearing in the 1962-1963 City Budget;

WHEREAS, this august Body on December 21, 1962, has passed Resolution No. 317 reverting from salary savings accruing to the Office of the City Auditor the sum of \$450.00 provided for salary differential of the Senior Clerk which should not have been the case and thus ought to be deleted from said Resolution No. 317;

"WHEREAS, the sum of \$1,200.00 to cover the deficiency in the appropriation for the position of Senior Clerk in the Office of the City Auditor can be well taken care of by salary savings appertaining to the Office of the City Auditor;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Abas, Lladoc and Samson;

## ORDINANCE NO. 3

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 11 (1962-1963 CITY BUDGET), SERIES OF 1962

BE IT ORDAINED by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City; That:

SECTION 1. - Section 1 of Ordinance No. 11 (1962-1963 City Budget), series of 1962, is hereby amended, further, in the manner provided for as follows:

Under the Office of the City Auditor, page 5, in connection with the position of Senior Clerk, the following should be deleted, to wit:

"(effective Jan. 1, 1963) .... ₱ 1,200.00"

so that the same line should read, viz:

II "One; Senior Clerk (\*) .... 7 2,400,00

SECTION 2. - EFFECTIVITY. Except where otherwise provided, this ordinance shall take effect as of the date of effectivity of Ordinance No. 11 (1962-1963 City Budget), series of 1962, i.e., July 1, 1962.

"RESOLVED, FURTHER, that the sum of Pl,200.00 covering the deficiency in the appropriation for the position of Senior Clerk in the Office of the City Auditor be reverted from out of the salary savings appertaining to said office to be made available for appropriation to carry out the provisions of this ordinance;

"RESOLVED, FURTHERMORE, that Resolution No. 317 dated December 21, 1962, of this august Body, be amended, also, by deleting the first item provided therein, to wit: "1. Salary Difference of Mr. Francisco D. Pepito, Senior Clerk, Office of the City Auditor, effective July 1, 1962 (instead of Jan. 1, 1963) at the rate of \$\mathbb{P}2,400.00 per annum .... \$\mathbb{P}245.00"

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Honorable Secretary of Finance, Manila; the Regional Director, East Visayan Region No V, Civil Service Commission, Cebu City; and likewise the City Treasurer and the City Auditor, both of Ormoc City;
