RESOLUTION NO. 67

"WHEREAS, there is a rising need to improve market fee collections without necessarily increasing the burden of taxation upon stall holders in the public market of Ormoc City inasmuch as the finances of the City Government are even hardly enough to support basic and essential improvements;

"WHEREAS, one such way of improving market fee collections is by declaring a certain day of the week as Special Market Day in Ormoc City which eventually would encourage industrial, agricultural, handicraft and many other allied home industries;

"NOW, THEREFORE, the Board, on motion of Councilor Conopio, seconded by Councilors Abas and Samson;

AN ORDINANCE DECLARING TUESDAY OF EVERY WEEK AS SPECIAL MARKET DAY (TABU) IN ORMOC CITY

BE IT ORDAINED, by Authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. There shall be a Special Market Day (Tabu) every Tuesday of the week in Ormoc City.

SECTION 2. For purposes of this ordinance, the vicinity in which the Special Market Day shall be held shall be the corners of Aviles and Rizal Streets up to the corners of Rizal and Lopez Jaena Streets, and the corners of Lopez Jaena and Real Streets and the corners of Real and Aviles Streets; HOWEVER, the vehicular traffic of Lopez Jaena Street from Rizal Street to Real Street shall be closed from 5:00 o'clock in the morning to 7:00 o'clock in the evening of said Special Market Day.

SECTION 3. The City Treasurer shall supervise the management and be responsible for the proper arrangement and assignment of stalls in the premises.


SECTION 4. The fees to be collected from the different occupants or owners of stalls or tiendas shall be based on the schedule of fees collected from stallholders inside the public market;

SECTION 5. This Ordinance shall take effect one (1) month after its approval.




