"The Board, on motion of Councilor Aviles, seconded by Councilor Abas;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. VI

AN ORDINANCE AMENDING ORDINANCE NO. V DATED APRIL 10, 1963, ENTITLED, "AN ORDINANCE DECLARING TUESDAY OF EVERY WEEK AS SPECIAL MARKET DAY (TABU) IN ORMOC CITY" AND FOR OTHER PURPOSES.

BE IT ORDAINED, by Authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

Section 1. Section 2 of Ordinance No. V dated April 10, 1963, entitled, "An Ordinance Declaring Tuesday of Every Week as Special Market Day (Tabu) in Ormoc City," is hereby amended to read as follows:

"Section 2. - For purposes of this ordinance, the vicinity in which the Special Market Day shall be held shall be the corners of Aviles and Rizal Streets up to the corners of Rizal and Lopez Jaena Streets and the corners of Lopez Jaena and Real Streets; PROVIDED, HOWEVER, that the vehicular traffic along Rizal Street from Aviles to Lopez Jaena Streets and along Lopez Jaena Street from Rizal to Real Streets, shall be closed from 5:00 o'clock in the morning to 7:00 o'clock in the evening of said special market day (tabu); and, PROVIDED, FURTHER, that a portion of 4 meters wide of Lopez Jaena Street on the Sacred Heart Hospital side from corner Rizal to Real Streets shall be opened for vehicular traffic; PROVIDED, FINALLY, that private or public vehicles, unless in answer to medical or emergency purposes, are prohibited from entering therein;

Section 2. This Ordinance shall take effect immediately upon approval.

Enacted, June 7, 1963.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Municipal Judge, the City Attorney, the Chief of Police, the City Treasurer, the City Auditor, and Dr. Alvaro I. Gutierrez, all of Ormoc City;
