RESOLUTION NO. 103

"WHEREAS, it has come to the knowledge of this august Body that complaints are being raised by stallholders on Rizal Street on the present setup of the special market day (tabu) every Tuesday the fact that they could no longer sell their wares as they are being blocked by vendors during Tuesdays;

"WHEREAS, this august Body finds it necessary to transfer the site of the special market day to another place for the benefit of the stallholders in the public market who are religiously paying their dues to the City Government;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilors Samson and Aviles;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. VII

AN ORDINANCE AMENDING FURTHER SECTION 2 OF ORDINANCE NO. V, AS AMENDED BY ORDINANCE NO. VI DATED JUNE 7, 1963, BY TRANSFERRING THE SITE OF THE SPECIAL MARKET DAY (TABU) AND FOR OTHER PURPOSES

BE IT ORDAINED, by Authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

Section 1. Section 2 of Ordinance No. V dated April 10, 1963, entitled, "An Ordinance Declaring Tuesday of Every Week as Special Market Day (Tabu) in Ormoc City," as amended by Ordinance No. VI dated June 7, 1963, is hereby amended, further, to read as follows:

"Section 2. - For purposes of this ordinance, the vicinity in which the Special Market Day shall be held shall be the portion of Rizal Street starting from the place in front of Atty. Lucilo A. Conui's residence to the corner of Osmeña and Rizal Streets; PROVIDED, HOWEVER, that the vehicular traffic along this portion of Rizal Street shall be closed from 5:00 o'clock in the morning to 7:00 o'clock in the evening of said special market day.

Section 2. This ordinance shall take effect immediately upon approval.

Enacted, July 5, 1963.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Municipal Judge, the City Attorney, the Chief of Police, the City Auditor, the City Treasurer and the Market Superintendent, all of Ormoc City;

"CARRIED. Seven affirmative votes; One abstention by Coun. Pongos."
