RESOLUTION NO. 104

"WHEREAS, Mrs. Eduarda Tomada, caterer for city prisoners, this City, in her letter dated July 3, 1963, has requested that the present allowance to prisoners of ₱0.60 per day be raised to at least ₱0.90 per day for reasons that this present rate is miserably low or perhaps the lowest given each prisoner;

"WHEREAS, this august Body finds the request of Mrs. Tomada noteworthy considering the prevailing prices of prime commodities where the present rate of allowance to each prisoner would not be sufficient to meet thereby behooving upon this Honorable Board to raise the standard of the prisoners human as they are who likewise need better food and comfort;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Aviles;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. VIII

AN ORDINANCE FIXING THE RATE OF SUBSISTENCE FOR EACH PRISONER AT NINETY CENTAVOS (₱0.90) PER DAY AND FOR OTHER PURPOSES

BE IT ORDAINED, by Authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

Section 1. There shall be fixed a regular rate of subsistence for each prisoner confined in the City Jail;

Section 2. For purposes of this ordinance the regular rate shall be Ninety Centavos (₱0.90) per day or Thirty Centavos (₱0.30) per meal for each city prisoner;

Section 3. This Ordinance shall take effect immediately upon approval.

Enacted, July 5, 1963.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Chief of Police, the City Treasurer, the City Auditor and Mrs. Eduarda Tomada, caterer, all of Ormoc City;
