"RESOLVED, as it is hereby resolved to adopt:

ORDINANCE NO. 10

AN ORDINANCE AMENDING FURTHER ORDINANCE NO. 9, SERIES OF 1963,
AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,
Philippines, pursuant to the provisions of Republic Act 179, as amended
by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Item 6, under Salaries and Wages, Office of the City Fis-
cal, page 6, Ordinance No. 9, s. 1963, Ormoc City Budget, to wit:

"One : Messenger-Janitor (from ₱1,200) ₱1,440.00"

is hereby amended to read as follows:

"One : Laborer ₱1,440.00"

SECTION 2. This Ordinance shall take effect immediately upon its
approval.

of Ormoc City;
