"WHEREAS, this august Body will remember having passed Resolution No. 201 on June 17, 1964, adopting Ordinance No. 14 imposing a production tax of \$0.20 per picul on the sale of centrifugal sugar and 1% on the gross sale of its derivatives and by-products produced by the Ormoc Sugar Co., Inc.;

* AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 11, SERIES OF 1964. ENTITIED "ANDORDINANCE INCREASING THE GRADUATED MUNICI-PAL. CAPITAL AND SALES TAX ON THE SALE OF MERCHANDISE IN THE CITY OF ORMOC AND FOR OTHER PURPOSES"

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Amendment. - Section 1, Ordinance No. 11, series of 1964, is hereby amended to read as follows:

"SECTION 1. Municipal tax. - There shall be paid to the City Treasurer on any sale of merchandise and others except abaca, hemp, copra, maguey, exported sugar, local centrifugal sugar or domestic sugar and its derivatives, and the like by any person, partnership, firm, association, corporation or entity engaged in business or the like in the City of Ormoc a graduated municipal, capital and sales tax per quarter as follows:

SECTION 2. Effectivity. - This Ordinance shall take effect immediately apon its approval.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, the City Fiscal and the City Judge, all of Ormoc City;
