"WHEREAS, after a careful deliberation this august Body considers it wise in the meantime to cut a sizeable portion of the City Mayor's discretionary fund by \$\mathbb{P}14,989.00\$ to be added to the \$\mathbb{P}2,291.00\$ surplus appropriation for outstanding bbligations in the Ormoc City Intermediate School to arrive at the aggregate sum of \$\mathbb{P}17,280100\$ with the hope that this deducted amount will be restored to the discretionary fund of the Honorable City Mayor after the National Government shall have reimbursed these obligations paid by the city for the support of the Ormoc City Intermediate School;

"WHEREAS, on this score we humbly believe there can be no critical objection from all quarters, much less from the Honorable City Mayor, to this extremely laudable aim of this Administration to accommodate these school children for whose welfare the Mayor has at heart and for whom he has convoked this august Body to this special session so that our constituents will be more than gratified by parting away \$\mathbb{P}\$14,989.00 from out of his discretionary fund;

"NOW, THEREFORE, the Board, on motion of Councilor Besabella, seconded by Councilors Du and Pongos;

## ORDINANCE NO. 19

AN ORDINANCE APPROPRIATING THE SUM OF TWO THOUSAND TWO HUNDRED NINETY—ONE PESOS (\$\frac{1}{2},291.00) FROM THE SURPLUS APPROPRIATION OF OUTSTANDING OBLIGATIONS IN THE ORMOC CITY INTERMEDIATE SCHOOL FUND AND REVERTING THE SUM OF FOURTEEN THOUSAND NINE HUNDRED EIGHTY—NINE PESOS (\$\frac{1}{2},989.00) FROM OUT OF THE DISCRETIONARY FUND OF THE CITY MAYOR FOR THE SALARIES OF NINE ADDITIONAL CLASSROOM TEACHERS IN THE ORMOC CITY INTERMEDIATE SCHOOL

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The amount of Two Thousand Two Hundred Ninety-One Pesos (\$\mathbb{P}2,291.00)\$ is hereby appropriated from out of the surplus appropriation of outstanding obligations in the Ormoc City Intermediate School Fund and the amount of Fourteen Thousand Nine Hundred Eighty-Nine Pesos (\$\mathbb{P}14,989)\$ is hereby reverted from out of the Discretionary Fund of the City Mayor, 1964-1965 Ormoc City Budget, or an aggregate sum of Seventeen Thousand Two Hundred Eighty Pesos (\$\mathbb{P}17,280.00)\$ to be made available for the salaries of nine additional classroom teachers in the Ormoc City Intermediate School (seven for Ormoc I and two for Ormoc II) at the rate of \$\mathbb{P}1,920.00\$ per annum each for the fiscal year 1964-1965.

SECTION 2. This Ordinance shall take effect immediately upon appro-
