RESOLUTION NO. 19

"WHEREAS, many retailers of liquor and intoxicating beverages have resented to the provisions of Ordinance No. 6, series of 1960, wherein they are included in the imposition of the tax therein prescribed which, according to them in a petition dated January 1, 1964, would amount to a multiple taxation inasmuch as they are already paying taxes for this particular line of business to the City;

"WHEREAS, after careful deliberation this august Body finds the complaint of the above-mentioned retailers worthy of consideration;

"NOW, THEREFORE, the Board, on motion of Councilor Pongos, seconded by Councilor Alfaro;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 2

AN ORDINANCE AMENDING FURTHER ORDINANCE NO. 6, SERIES OF 1960, ENTITLED "AN ORDINANCE IMPOSING A TAX ON THE SALE OF LIQUOR AND INTOXICATING BEVERAGES IN ORMOC CITY"

BE IT ORDAINED by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. In the first paragraph of Section 1 of Ordinance No. 6, series of 1960, the comma (,) between the words "manufacturers" and "wholesalers" should be deleted and in its stead the word "and" should be inserted; and the words "and retailers" immediately following together with the comma (,) should be deleted so that said first paragraph should read:

"SECTION 1. There shall be collected on any sale of liquor work or intoxicating beverages of any form in Ormoc City by manufacturers and wholesalers for purposes of a municipal tax the following rates:

SECTION 2. Section 3 of Ordinance No. 6, series of 1960, is hereby amended to read as follows:

"SECTION 3. Manner of Bayment. - The tax imposed in Section 1 hereof shall be collected from manufacturers and wholesalers only for sales made directly to retailers and to end-users or consumers."
