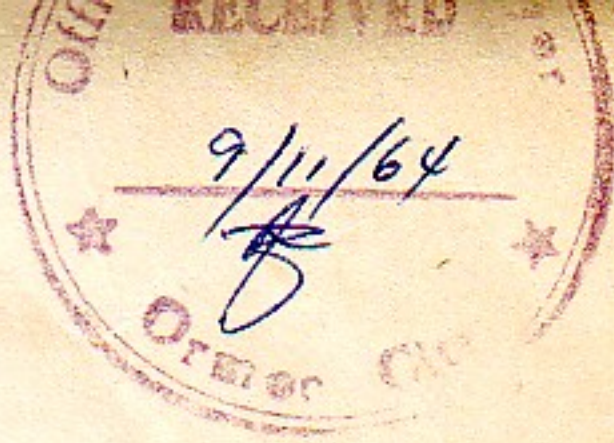


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE FIFTH

RESOLUTION NO. 257

"WHEREAS, Mrs. Eduarda vda. de Arradaza, caterer for city prisoners, in a letter dated August 28, 1964, has requested the amendment of Ordinance No. VIII, series of 1963, by increasing the present rate from ₱0.30 to ₱0.40 per meal or from ₱0.90 to ₱1.20 per day for each city prisoner considering the ever spiraling up of prices of prime commodities nowadays;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilors Tugonon, Kierulf and Aviles;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 21

AN ORDINANCE AMENDING SECTION 2 of ORDINANCE NO. VIII, SERIES OF 1963, ENTITLED 'AN ORDINANCE FIXING THE RATE OF SUBSISTENCE FOR EVERY PRISONER AT NINETY CENTAVOS PER DAY AND FOR OTHER PURPOSES"

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Section 2 of Ordinance No. VIII, series of 1963, is hereby amended to read as follows:

"SECTION 2. The regular rate for each city prisoner shall be ₱0.40 per meal or ₱1.20 per day in the City Jail."

SECTION 2. This ordinance shall take effect immediately upon its approval.

ENACTED, September 9, 1964.
