RESOLUTION NO. 266

"The Board, on motion of Councilor Du, seconded by Councilors Alfaro and Besabella;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 22

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 14, SERIES OF 1964, ENTITLED "AN ORDINANCE IMPOSING A PRODUCTION TAX OF TWENTY CENTAVOS (P0.20) PER PICUL ON THE SALE OF CENTRIFUGAL SUGAR AND ONE PERCENTUM (1%) ON THE GROSS SALE OF ITS DERIVATIVES AND BY-PRODUCTS PRODUCED BY THE ORMOC SUGAR COMPANY, INCORPORATED, AND FOR OTHER PURPOSES"

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 129, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Amendment. - Section 2 of Ordinance No. 14, series of 1964, entitled "An Ordinance Imposing a Production Tax of Twenty Centavos (P0.20) per Picul on the Sale of Centrifugal Sugar and One Percentum (1%) on the Gross Sale of its Derivatives and By-products Produced by the Ormoc Sugar Company, Incorporated, and for other Purposes," is hereby amended to read as follows:

"SECTION 2. Time and manner of payment and penalty for delinquency. - The city tax herein prescribed shall be payable without penalty within twenty (20) days after the close of every quarter for which the tax is due. The tax due on sugar shall be obligated on the quedans sold and the tax due on the derivatives and by-products shall be based on the sales from records obtainable, both to be paid to the City Treasurer within the said twenty (20) days after the close of every quarter for which the taxes are due. Failure to pay the taxes within the prescribed time shall render the taxpayer subject to a surcharge of fifty percentum (50%) for the first offense and one hundred percentum (100%) for subsequent failures to pay within the prescribed period."

SECTION 2. Effectivity - This Ordinance shall take effect immediately upon its approval.
