ORDINANCE NO. 23

AN ORDINANCE AMENDING (C-6) ASSESSMENT DEPARTMENT AND (C-15) POLICE DEPARTMENT, SECTION 1 OF ORDINANCE NO. 18, SERIES OF 1964, OTHERWISE KNOWN AS THE 1964-1965 ORMOC CITY BUDGET, AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

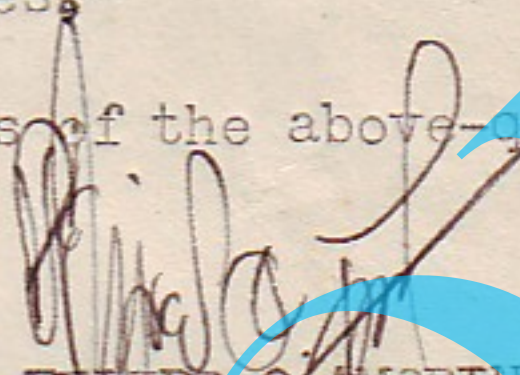
SECTION 3. This Ordinance shall take effect immediately upon its approval.

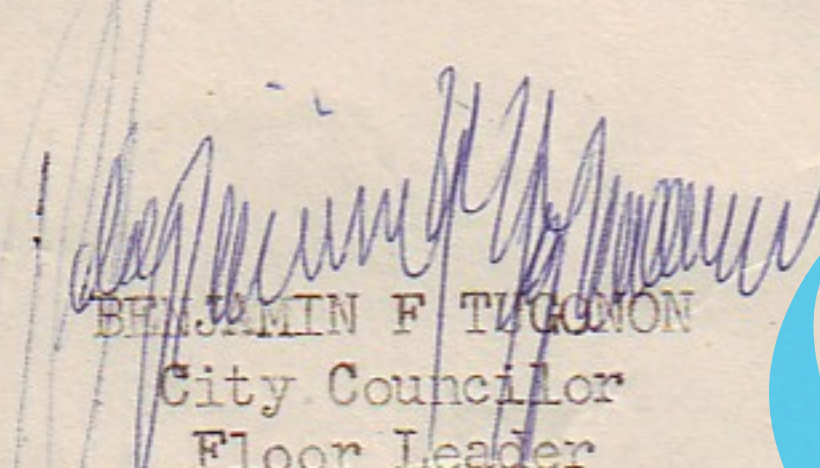

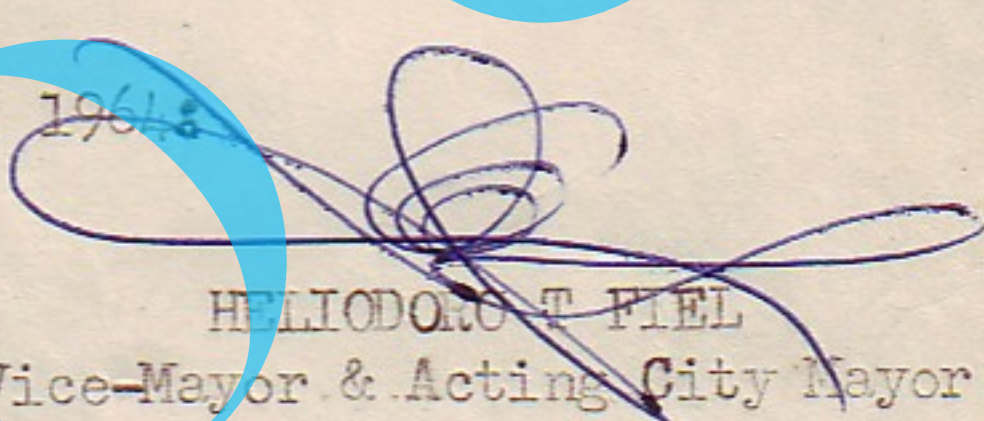

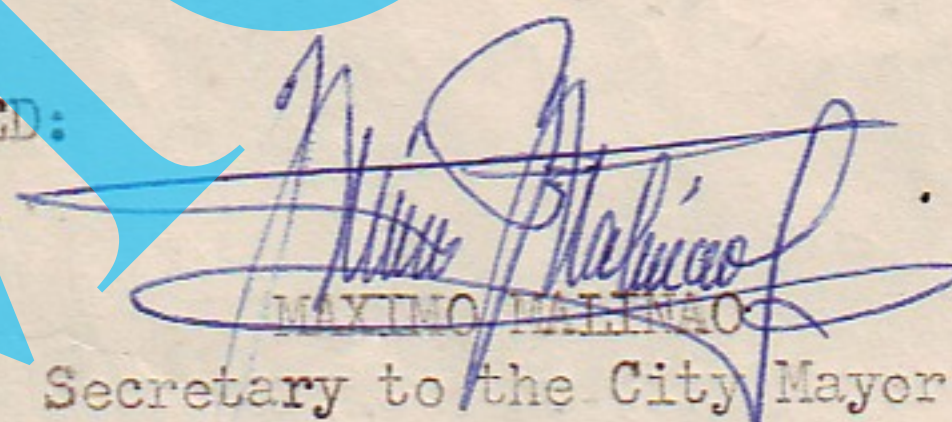
