"RESOLVED, to adopt:

ORDINANCE NO. 24

AN ORDINANCE AMENDING ORDINANCE NO. 7, SERIES OF 1964

Amended
Res 128-238-57968

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The title of Ordinance No. 7, series of 1964, is hereby amended to read as follows:

"AN ORDINANCE IMPOSING A STORAGE TAX OF TWO PESOS AND FIFTY CENTAVOS (P2.50) FOR EVERY TON OF HEMP, MAGUEY, AND THE LIKE, AND FIFTEEN CENTAVOS (P0.15) FOR EVERY SACK OF COPRA PURCHASED, SOLD, STORED, SHIPPED OR KEPT IN THE CITY OF ORMOC AND FOR OTHER PURPOSES"

SECTION 2. Section 1 of Ordinance No. 7, series of 1964, is hereby subsequently amended to read as follows:

"SECTION 1. City tax. - Any person, partnership, firm, association or corporation duly licensed or engaged in buying and/or selling copra, hemp, maguey, and the like, who shall hold, keep or store the same at his place of business, bodega or elsewhere within the jurisdiction of the City of Ormoc, shall pay to the City Treasurer a storage tax of Two Pesos and Fifty Centavos (P2.50) for every ton of hemp, maguey, and the like, and Fifteen Centavos (P0.15) for every sack of copra purchased, sold, stored, shipped or kept by any person or entity subject to this ordinance."

SECTION 3. This Ordinance shall take effect immediately upon its approval.

ENACTED, September 23, 1964.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the City Judge, the City Fiscal, the City Treasurer, the City Auditor, and all concerned, Ormoc City, for their information and guidance."

"CARRIED. Six affirmative votes registered by Councilors Alfaro, Kierulf, Abas, Besabella and Du, including the Floor Leader and Presiding Officer; one abstention registered by Councilor Aviles."
