RESOLUTION NO. 296

"WHEREAS, the City Health Officer, this City, in his communication dated 12, 1964, has called the attention of this august Body that instead of the usual three sanitarians, only two were provided for in the recently approved 1964-1965 Ormoc City Budget due to some oversight on the part of the Board;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 25

AN ORDINANCE AMENDING ITEM NUMBER EIGHT UNDER (C-17) HEALTH DEPARTMENT, SECTION ONE, ORDINANCE NO. 18, SERIES OF 1964, PROVIDING FOR A SUPPLEMENTAL BUDGET TO ITS EFFECT

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Item No. 8 under the Health Department, page 11, under Section 1, Ordinance No. 18, series of 1964, otherwise known as the 1964-1965 Ormoc City Budget, is hereby amended to read as follows:

"Item No. 8 - Three (3) Acting Sanitarians @ P1,680.00
(from Sanitarians @ P1,440.00) P 5,040.00"

SECTION 2. The sum of P1,680.00 is hereby appropriated in a supplemental budget to cover the deficiency in the original appropriation-ordinance to be taken from out of the unappropriated balance in the general fund.

SECTION 3. This Ordinance shall take effect as of July 1, 1964.
