"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 26

AN ORDINANCE AMENDING ITEM NUMBER SEVEN UNDER (C-3) AUDITING DEPARTMENT, SECTION ONE, ORDINANCE NO. 18, SERIES OF 1964

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Item No. 7 under (C-3) Auditing Department, page 6, under Section 1, Ordinance No. 18, series of 1964, otherwise known as the 1964-1965 Ormoc City Budget, is hereby amended to read as follows:

"Item No. 7 - One (1) Laborer at ₱1,440.00 (new, effective Sept. 1, 1964) ..... ₱1,200.00"

SECTION 2. This Ordinance shall take effect as of September 1, 1964.
