

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 27

AN ORDINANCE REVERTING THE SUM OF \$4,000 FROM ITEM 14, QG-16) FIRE DEPARTMENT, 1964-1965 ORMOG CITY BUDGET, FOR ADDITIONAL DEPOSIT WITH DIVERSIFIED TRADE, INC., MANILA, FOR TWO RECONDITIONED TOYOTA FIRE TRUCKS

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of \$4,000 is hereby reverted from Item No. 14, provision for one (1) Fire Truck, locally mounted, Fire Department, page 11, 1964-1965 Ormoc City Budget, to be made available for additional deposit with the Diversified Trade, Inc., Manila, in connection with the purchase of two reconditioned fire trucks for Ormoc City.

SECTION 2. The City Treasurer is hereby authorized to effect a supplementary budget in connection with this appropriation and prepare the necessary payment in favor of the Diversified Trade, Inc., Manila.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
