"Item No. 4, One (1) Fireman (from ~~P1,440.00~~) P1,680.00"

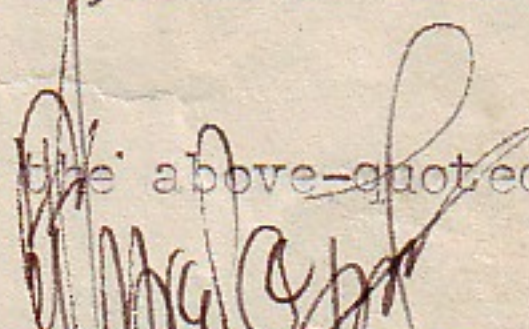
SECTION 2. This Ordinance shall take effect immediately as of July

"CARRIED UNANIMOUSLY."

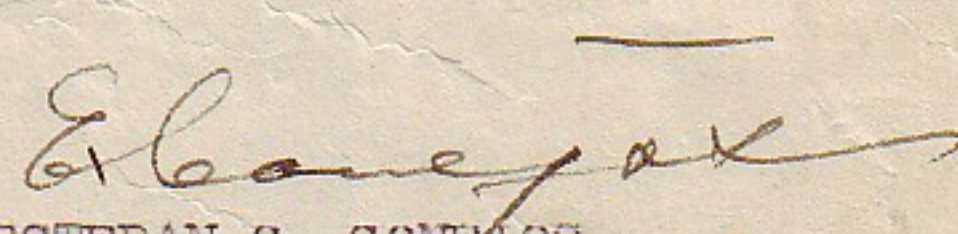
