RESOLUTION NO. 306

"WHEREAS, the Chief of Police, this City, has in a letter of even date requested an appropriation of ₱1,242.70 for the purchase of uniform of seventeen new members of his force;

"WHEREAS, from unfilled positions in the Police Department for the period from September 1 to 15, 1964, namely, 14 new patrolmen and 6 new patrolmen first class at ₱60 each, the sum of ₱1,260 has been accrued in salary savings which if added by the unexpended balance of ₱52.60 for uniform would more than sufficiently meet the necessary sum for the appropriation requested by the Chief of Police for new police uniform;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 29

AN ORDINANCE REVERTING THE SUM OF ₱1,242.70 FROM SALARY SAVINGS AND UNEXPENDED BALANCE FOR POLICE UNIFORM IN THE POLICE DEPARTMENT AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱1,242.70 is hereby reverted from salary savings and unexpended balance for police uniform to be made available for appropriation for the purchase of police uniform for the seventeen new members of the Ormoc City Police Department.

SECTION 2. This ordinance shall take effect immediately upon its approval.

ENACTED, October 21, 1964.
