RESOLUTION NO. 28

"WHEREAS, Councilor Abas, Chairman of the Committee on Finance of this august Body, has reported that as of December 31, 1963, the City General Fund has incurred a deficit of ₱67,237.11 while the City Intermediate ~~School~~ Fund has also incurred a deficit of ₱38,726.59, making a total deficit in the staggering sum of ₱107,963.70;

"WHEREAS, this precarious situation of the city finances is endangering the operation of the City Government so much so that this august Body finds it inevitable to abolish some positions which are deemed unessential at the sacrifice of other offices which shall then temporarily assign their personnel to take charge of positions affected by the abolition without necessarily changing their appointments in order to lessen the deficit little by little if not entirely overcome and offset in a not too distant future;

"WHEREAS, the position of Municipal Librarian is, to start with, considered foremost among the unessential positions considering that the same could be held or handled by any other employee of the City Government as it was a few years ago when the public library was under the charge of an employee of the Office of the City Mayor;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Besabella;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 3

AN ORDINANCE ABOLISHING THE POSITION OF MUNICIPAL LIBRARIAN

BE IT ORDAINED by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The position of Municipal Librarian, for purposes of economy, is hereby abolished.

SECTION 2. The City Mayor shall hereinafter designate an in-charge of the City Library any employee from a department without necessarily changing his appointment to the position presently held with the consent of the department head concerned.

SECTION 3. This Ordinance shall take effect immediately upon its approval.

ENACTED, January 20, 1964.


"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Municipal Librarian, the City Treasurer, the City Auditor, all of Ormoc City, and, likewise, the Director of Public Libraries, Manila;

"CARRIED. Five affirmative votes registered by Councilors Tugonon, Kierulf, Abas, Besabella and Du; Two negative votes registered by Councilors Aviles and Pongos."


