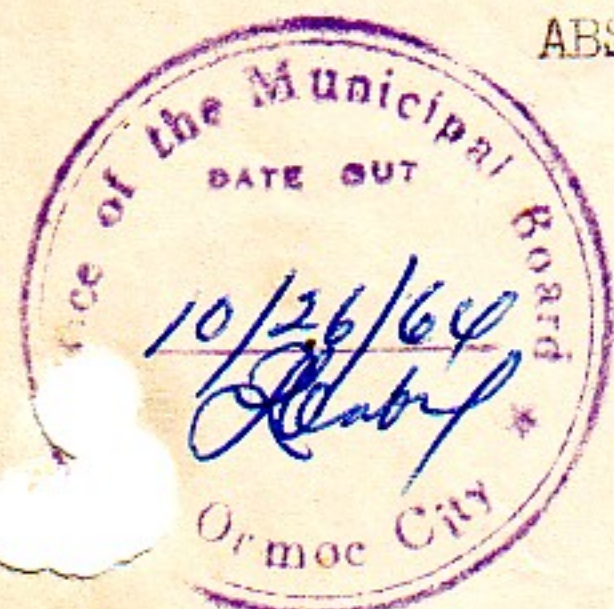

ORDINANCE NO. 30

AN ORDINANCE AMENDING ITEM 14, (C-2) MUNICIPAL BOARD, UNDER
SECTION 1 OF ORDINANCE NO. 18, SERIES OF 1964, AND FOR
OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,
Philippines, pursuant to the provisions of Republic Act 179, as amended
by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Item No. 14, (C-2) MUNICIPAL BOARD, page 5, under Section
1 of Ordinance No. 18, series of 1964, otherwise known as the 1964-1965
Ormoc City Budget, is hereby amended to read as follows:

"Item No. 14, One (1) Clerical Aide at ₱1,440.00 (new,
effective September 1, 1964) ₱ 1,200.00"

SECTION 2. This Ordinance shall take effect as of September 1,
1964.
