ORDINANCE NO. 32

AN ORDINANCE REVERTING SALARY SAVINGS OR TRAVELING EXPENSES IN THE POLICE DEPARTMENT FOR BOARD AND LODGING AND OTHER IN-CIDENTAL EXPENSES OF TWO PATROLMEN ATTENDING TWO WEEKS SEMI-NAR ON FISHERIES LAW IN TACLOBAN CITY AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of \$200 is hereby reverted from out of salary savings or traveling expenses accruing to the Police Department to be made available for appropriation for board and lodging and other incidental expenses of Patrolmen Garciano Arnulfo and Dominador Conopio who are now attending a two-week seminar on Fisheries Law in Tacloban Citys

SECTION 2. This Ordinance shall take effect immediately upon its approval.
