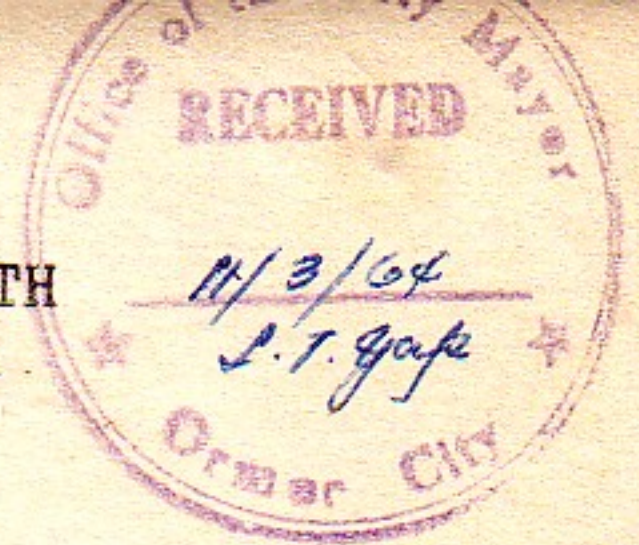


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE FIFTH

RESOLUTION NO. 321

"The Board, on motion of Councilor Abas, seconded by Floor Leader Tugonon and Councilor Du;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 33

AN ORDINANCE AMENDING FURTHER ORDINANCE NO. 18, CURRENT SERIES, OTHERWISE KNOWN AS THE 1964-1965 ORMOC CITY BUDGET, AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Item No. 7 under (C-3) AUDITING DEPARTMENT, page 6, under Section 1 of Ordinance No. 18, as amended by Ordinance No. 26, both series of 1964, is hereby abolished (position of one Laborer).

SECTION 2. Item No. 4 under (C-1) OFFICE OF THE CITY MAYOR, page 4, under Section 1 of Ordinance No. 18, series of 1964, is hereby amended to read as follows:

"Item No. 4 - One (1) Assistant of the Secretary to the City Mayor (from ₱1,440.00) ₱ 1,680.00"

SECTION 3. Item No. 9 under (C-1) OFFICE OF THE CITY MAYOR, page 4, under Section 1 of Ordinance No. 18, series of 1964, is hereby amended to read as follows:

"Item No. 9 - One (1) Janitor (from ₱1,440.00) ₱ 1,680.00"

SECTION 4. One more new position of Laborer under (C-1) OFFICE OF THE CITY MAYOR, page 4, under Section 1 of Ordinance No. 18, series of 1964, is hereby created with compensation at the rate of ₱1,440.00 per annum effective October 1, 1964, so that a new item to be known as Item No. 10-A is hereby added, to read as follows:

"Item No. 10-A - One (1) Laborer at ₱1,440.00 (new, effective October 1, 1964) ₱ 1,080.00"

SECTION 5. Item No. 12 under (C-2) MUNICIPAL BOARD, page 5, under Section 1 of Ordinance No. 18, series of 1964, is hereby amended to read as follows:

"Item No. 12 - One (1) Confidential Agent of the Board at ₱2,400.00 (new effective September 1, 1964) ₱ 2,000.00"



SECTION 6. Item No. 14 under (C-2) MUNICIPAL BOARD, page 5, under Section 1 of Ordinance No. 18, series of 1964, as amended by Ordinance No. 30, current series, is hereby amended further to read as follows:

"Item No. 14 - One (1) Assistant Confidential Agent of the Board at P1,440.00 (new, effective September 1, 1964) P 1,200.00"

SECTION 7. A new position of Laborer under (C-24) CITY LIBRARY, (under the Office of the City Mayor), page 12, under Section 1 of Ordinance No. 18, series of 1964, is hereby created with compensation at the rate of P1,440.00 per annum effective November 1, 1964, so that a new item to be known as Item No. 1, under Salaries and Wages, is hereby added, to read as follows:

"Item No. 1 - One Laborer at P1,440.00 (new, effective November 1, 1964) P 960.00"

SECTION 8. The sum of Two Thousand Forty Pesos (P2,040) corresponding to the salaries provided for in Sections 4 and 7 hereof is hereby reverted and/or appropriated from out of salary savings and from other funds not otherwise appropriated in the City treasury.


SECTION 9. Effectivity. - Except where otherwise provided, this Ordinance shall take effect as of July 1, 1964.


