ORDINANCE NO. 34

AN ORDINANCE AMENDING ITEM NO. 20, C-2, MUNICIPAL BOARD, PAGE 5, UNDER SECTION 1, ORDINANCE NO. 18, SERIES OF 1964, AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 169, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Item No. 20, C-2, MUNICIPAL BOARD, page 5, under Section 1 of Ordinance No. 18, series of 1964, is hereby amended to read as follows:

"Item No. 20 - Gasoline Allowance for the Presiding Officer and the Eight (8) City Councilors for their private, loaned and/or hired motor vehicles in the performance of their respective duties at ₱100 per month each effective October 1, 1964, viz-a-viz:

a) Hon. Heliodoro T. Fiel (private motor vehicle)	₱900.00
b) Hon. Benjamin F. Tugonon (private motor vehicle)	900.00
c) Hon. Narciso C. Alfaro (private motor vehicle)	900.00
d) Hon. Pelagio C. Kierulf (private motor vehicle)	900.00
e) Hon. Francisco D. Abas (private SOLEX scooter and/or loaned or hired motor vehicle)	900.00
f) Hon. Anastacio D. Besabella (loaned motor vehicle)	900.00
g) Hon. Marciano S. Du (private motor vehicle)	900.00
h) Hon. Francisco D. Aviles (loaned motor vehicle)	900.00
i) Hon. Benjamin T. Pongos (private motor vehicle)	900.00 ₱8,100.00"

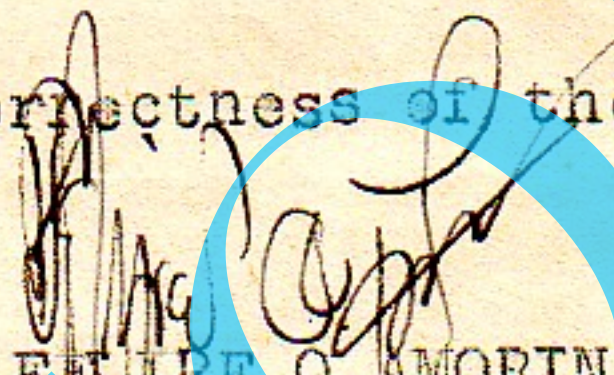
SECTION 2. This Ordinance shall take effect as of October 1, 1964.

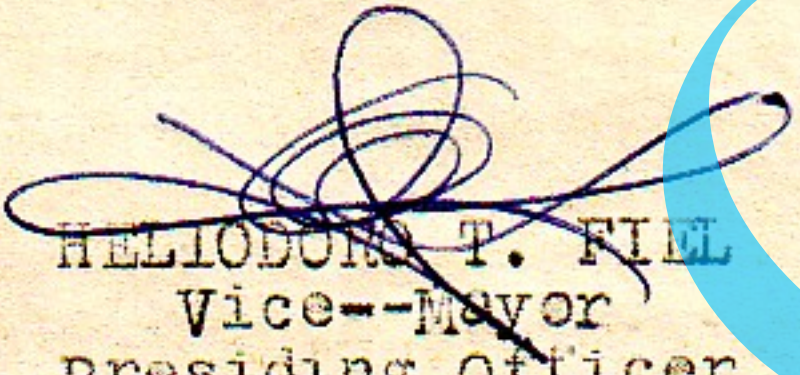

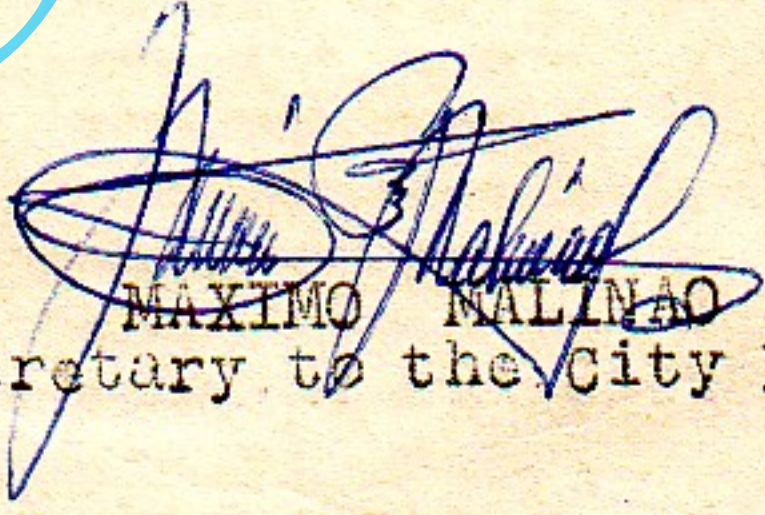
