RESOLUTION NO. 328

"WHEREAS, in the implementation of the Socio-Economic Development Program of the Republic of the Philippines which in President Macapagal's own words, "shall place the country on the road to prosperity for all our people," the local government of Ormoc City bids fair to play a very important role in the realization of said program;

"WHEREAS, this august Body is in dire need, among others, of at least three (3) dump trucks for use as garbage trucks in order to keep up with the garbage collection and disposal considering that the present dilapidated one cannot cope with the tremendous job of clearing all rubbish, refuse, and the like;

"WHEREAS, this Board would like to avail itself of the opportunity to acquire three dump trucks for this purpose from the U.S. Agency for International Aid, thru the National Economic Council, Manila, considering that the City will only shoulder the maintenance and repair of these equipment and to buy them from commercial heavy equipment dealers would mean a heavy drain in the city coffer;

"WHEREAS, this Body will remember having provided for the purchase of one garbage truck amounting to ₱12,000.00 in the current fiscal budget on Item No. 3, C-27, Garbage Collection and Disposal, page 13 of said budget;

"WHEREAS, on the second thought, after representations have been made with the U.S. Agency for International Aid and the National Economic Council, this Body has deemed it fitting and proper to dispense with the purchase of one garbage truck even as this same body desires to acquire three dump trucks from the two offices above-mentioned at even a lesser expense taking into account that we have got only to provide for their maintenance and repair with our own City Engineering Motor pool to constitute their base of operation;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Floor Leader Tugonon and Councilor Alfaro;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 35

AN ORDINANCE REVERTING THE AMOUNT OF ₱9,000.00 FROM
ITEM NO. 3, C-17, GARBAGE COLLECTION AND DISPOSAL,
UNDER SECTION 1 OF ORDINANCE NO. 18, SERIES OF 1964,
AND FOR OTHER PURPOSES



BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The amount of ₱9,000.00 or so much thereof is hereby reverted from Item No. 3, C-27, Garbage Collection and Disposal, page 13, under Section 1 of Ordinance No. 18, series of 1964, to be made available for appropriation for the repair and maintenance of three dump trucks at the rate of ₱3,000.00 per dump truck from the U.S. Agency for International Aid, thru the National Economic Council, Manila.

SECTION 2. The City Treasurer is hereby authorized to issue a certificate of availability of funds in connection with the acquisition of three (3) dump trucks from the Manila offices above-mentioned.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
