RESOLUTION NO. 335

"The Board, on motion of Floor Leader Tugonon, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 38

AN ORDINANCE IMPOSING PARKING FEES TO ALL AC, PUJ, AND PUB VEHICLES UTILIZING SPECIFIC PORTIONS OF STREETS FOR PARKING PLACES WITHIN ORMOC CITY AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Parking fee. - There shall be paid to the City Treasurer a parking fee by operators of AC, PUJ, and PUB vehicles for every vehicle utilizing specific portions of streets for parking purposes within Ormoc City, as follows:

- a) For every AC vehicle, Ten Centavos (P0.10) per day;
- b) For every PUJ vehicle, Twenty Centavos (P0.20) per day;
- c) For every PUB vehicle with registered passenger capacity of 30 or less, Thirty Centavos (P0.30) per day;
- d) For every PUB vehicle with registered passenger capacity of 31 to 40, Forty Centavos (P0.40) per day; and
- e) For every PUB vehicle with registered passenger capacity of 41 and up, Fifty Centavos (P0.50) per day.

SECTION 2. Definition of term. - By the term "specific portions of streets" is meant:

1. On C. Aviles Street, from its corner of Rizal Street to its opposite corner of A. Bonifacio Street;
2. On C. Aviles Street, from its corner of Real Street to its opposite corner of A. Mabini Street;
3. On G. Lopez Jaena Street, from its corner of Rizal Street to its opposite corner of Real Street; and
4. On Corner Real and G. Lopez Jaena Streets alongside La Leyteña Store.

SECTION 3. Time and manner of payment. - The parking fee herein prescribed shall be payable upon arrival of any vehicle subject to this Ordinance on the parking places defined in Section 2 hereof.

SECTION 4. Penalty for violation. - Any violation of the provisions of this Ordinance shall be punishable by a fine of not exceeding Five Pesos (P5.00) for the first offense and Ten Pesos (P10.00) for subsequent offenses.

SECTION 5. Construction of this Ordinance. - If any part or section of this Ordinance shall be declared unconstitutional or ultra-vires, such part or section shall not invalidate any other provisions hereof.


SECTION 6. Effectivity. - This Ordinance shall take effect immediately upon its approval.




