RESOLUTION NO. 337

"WHEREAS, this august Body will remember having passed Resolution No. 271 appropriating the aggregate sum of ₱2,500 for the completion of the Ormoc City High School building including installation of water pipes to said school but which, through clerical error, no provisions were made as to the source of fund from which said sum is appropriated thereby consequently making the City Treasurer communicate with this august Body inquiring clarification;

"NOW, THEREFORE, the Board, on motion of Councilor Besabella, seconded by Floor Leader Tugonon;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 40

AN ORDINANCE APPROPRIATING THE SUM OF ₱2,500 FROM UNAPPROPRIATED BALANCE IN THE GENERAL FUND FOR THE COMPLETION OF THE ORMOC CITY HIGH SCHOOL BUILDING INCLUDING WATER PIPES INSTALLATION AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The aggregate sum of ₱2,500 or so much thereof is hereby appropriated from out of funds not otherwise appropriated in the city treasury for the purposes hereunder provided, viz: (a) ₱2,000 for the completion of the Ormoc City High School building and (b) ₱500 for installation of water pipes to the Ormoc City High School.

SECTION 2. This Ordinance shall take effect immediately upon approval.

ENACTED, November 11, 1964.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Acting Teacher-In Charge, Ormoc City High School, the City Engineer, the NWSA Supervisor, the City Treasurer and the City Auditor, all of Ormoc City;
