ORDINANCE NO. 41

AN ORDINANCE AMENDING ITEM NO. 17, C-5, FINANCE DEPARTMENT, PAGE 7, UNDER SECTION 1 OF ORDINANCE NO. 18, SERIES OF 1964, AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Item No. 17, C-5, FINANCE DEPARTMENT, page 7, under Section 1 of Ordinance No. 18, series of 1964, is hereby amended to read as follows:

"Item No. 17 - One (1) Janitor (from ₱1,440.00) ..... ₱ 1,680.00"

SECTION 2. This Ordinance shall take effect as of July 1, 1964.
