"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 44

AN ORDINANCE REVERTING THE SUM OF ₱937.50 FROM SALARY SAVINGS  
ACCRUING TO THE FIRE DEPARTMENT FOR PURPOSES OF A SUPPLE-  
MENTAL BUDGET FOR CONTINGENT EXPENSES IN SAID DEPARTMENT

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,  
Philippines, pursuant to the provisions of Republic Act 179, as amended  
by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱937.50 or so much thereof is hereby reverted  
from salary savings accruing to the Fire Department for purposes of a  
supplemental budget for contingent expenses in the said department to be  
made available in the manner hereunder provided, viz:

1) Gasoline allowance for the new fire unit .....	₱ 150.00
2) Extension of garage .....	600.00
3) Insurance premium from October, 1964, to June, 1964 (renewal) .....	187.50
Total .....	₱ 937.50

SECTION 2. This ordinance shall take effect immediately upon its  
approval.
