

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO.

AN ORDINANCE REVERTING THE SUM OF ₱24,484.72 REPRESENTING UNEXPENDED BALANCE IN THE ROAD AND BRIDGE FUND AS OF JUNE 30, 1964, TO THE GENERAL FUND AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of \$24,484.72 or so much thereof representing unexpended balance in the Road and Bridge Fund as of June 30, 1964, is hereby reverted to the General Funds

SECTION 2. As a consequence of this reversion, the sum of \$7,710.00 is hereby appropriated for payment of road-right-of-way claims in the manner hereunder provided, viz-a-viz:

a) To Generosa Conui et al on Lots Nos. 714 and 715 abutting Mabini, Burgos and Aviles Streets \$ 6,840.00

b) To Generosa Conui et al on Lot No. 493 abutting Bonifacio Street 870.00 Total ₱ 7.710.00

SECTION 3. This Ordinance shall take effect immediately upon its approval.
