RESOLUTION NO. 345

"The Board, on motion of Councilor Abas, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 45

AN ORDINANCE REVERTING THE SUM OF ₱24,484.72 REPRESENTING UNEXPENDED BALANCE IN THE ROAD AND BRIDGE FUND AS OF JUNE 30, 1964, TO THE GENERAL FUND AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱24,484.72 or so much thereof representing unexpended balance in the Road and Bridge Fund as of June 30, 1964, is hereby reverted to the General Fund;

SECTION 2. As a consequence of this reversion, the sum of ₱7,710.00 is hereby appropriated for payment of road-right-of-way claims in the manner hereunder provided, viz-a-viz:
