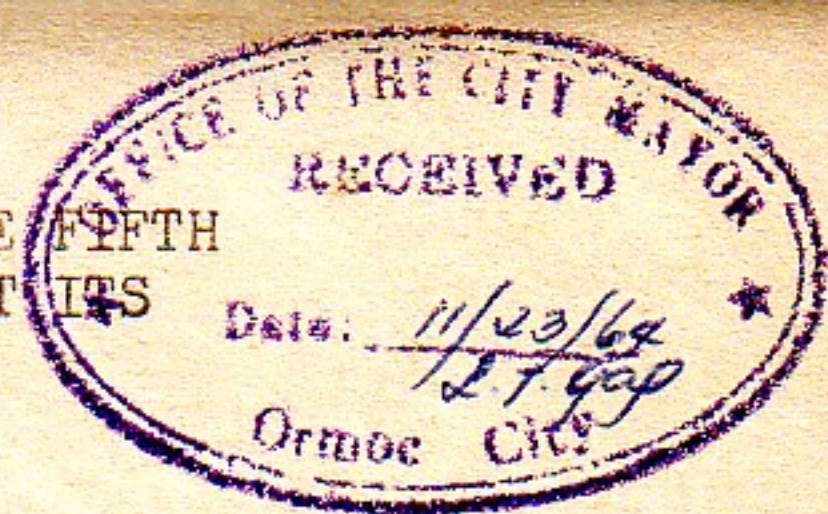

"The Board, on motion of Councilor Abas, seconded by Floor Leader Tugonon and Councilor Du;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 465-76

AN ORDINANCE REVERTING THE SUM OF ₱16,774.72 IN THE GENERAL FUND RESULTING FROM REVERSION OF UNEXPENDED BALANCE AND SUBSEQUENT PAYMENTS FOR ROAD-RIGHT-OF-WAY CLAIMS FOR PURPOSES OF A SUPPLEMENTAL BUDGET FOR CAPITAL OUTLAYS ON CEMENTING OF STREETS

BE IT ORDAINED, by authority of the Municipal Board, of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱16,774.72 or so much thereof in the General Fund resulting from the reversion of unexpended balance in the Road and Bridge Fund as of June 30, 1964, and payments of road-right-of-way claims, is hereby reverted for purposes of a supplemental budget for Capital Outlays particularly in Item No. 2, page 14, Section 1, Ordinance No. 18, series of 1964, otherwise known as Cementing of City Streets.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
