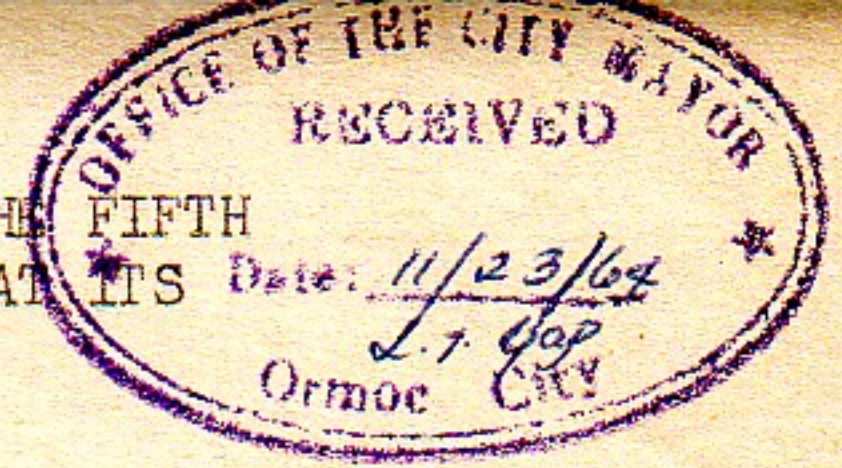

RESOLUTION NO. 349

"The Board, on motion of Councilor Abas, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. ~~46~~-47

"AN ORDINANCE APPROPRIATING THE SUM OF P500 FROM OUT OF DORMANT
ACCOUNTS TO BE MADE AVAILABLE FOR BARRIO AND SCHOOL AID
TO HUGPA, ORMOC CITY

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,
Philippines, pursuant to the provisions of Republic Act 179, as amended
by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of P500 or so much thereof is hereby appropriat-
ed from out of dormant accounts in the city treasury to be made availa-
ble for Barrio and School Aid to Hugpa, Ormoc City, for the repair of the
community school building and for other improvements thereat.

SECTION 2. This Ordinance shall take effect immediately upon its
approval

ENACTED, November 18, 1964.
