ORDINANCE NO. 45

AN ORDINANCE REVERTING THE AMOUNT OF ₱1,000 FROM ITEM NO. 3, C-27, GARBAGE COLLECTION AND DISPOSAL, PAGE 13, UNDER SECTION 1 OF ORDINANCE NO. 18, SERIES OF 1964, FOR PURPOSES OF BARRIO AND SCHOOL AID TO LINAO, ORMOC CITY

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The amount of ₱1,000 or so much thereof is hereby reverted from Item No. 3, C-27, Garbage Collection and Disposal, page 13, under Section 1 of Ordinance No. 18, series of 1964, to be made available for appropriation for Barrio and School Aid to Linao, this City, for the construction, improvement, addition and/or completion of repair of community school buildings, rooms or other school projects.

ORDINANCE NO. 48

AN ORDINANCE AMENDING ITEMS 6 AND 9, (C-16) FIRE DEPARTMENT,
PAGE 11, UNDER SECTION 1 OF ORDINANCE NO. 18, S. 1964

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Items 6 and 9, (C-16) Fire Department, page 11, under Section 1 of Ordinance No. 18, series of 1964, are hereby amended to read as follows:

"Item No. 6 - One (1) Driver (from ₱1,440.00)	₱ 1,680.00
"Item No. 9 - One (1) Fireman-Electrician Helper (from ₱1,440.00)	1,680.00"

PROVIDED, HOWEVER, that these amendments do not carry with them the corresponding changes of duties and responsibilities.
