RESOLUTION NO. 368

"WHEREAS, the City Auditor in his letter dated December 10, 1964, has invited the attention of this august Body to the provisions of Section 627 of the Revised Manual of Instructions to Treasurers, regarding the appropriation for the discretionary fund of the City Mayor falling under the functional expense classification, C-1-r, so that he requested that all charges against the discretionary fund appropriation of the City Mayor be for the purpose as expressly stated and specified in the resolution or ordinance; (Resolution No. 233-Ordinance No. 18);

"WHEREAS, the City Treasurer in his letter of December 11, 1964, has, likewise, called the attention of this august Body to Section 7 of Republic Act 179, otherwise known as the Charter of Ormoc City, providing a net commutable allowance of not exceeding ₱2,000 for the City Mayor per annum illegalizing in this connection our Resolution No. 332-Ordinance No. 37, current series, which gives an excess of ₱1,800 for the commutable allowance of the City Mayor;

"NOW, THEREFORE, the Board, on motion of Councilor Abas; seconded by Councilor Kierulf;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 49

AN ORDINANCE AMENDING ITEM NO. 11, (C-1) OFFICE OF THE CITY MAYOR, PAGE 4, UNDER SECTION 1 OF ORDINANCE NO. 18 AND REPEALING ORDINANCE NO. 37, BOTH SERIES OF 1964, AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Ordinance No. 37, series of 1964, is hereby repealed so that Item No. 13, (C-1) Office of the City Mayor, page 4, under Section 1 of Ordinance No. 18, series of 1964, otherwise known as the City Mayor's Commutable Allowance will remain as is in the appropriated sum of ₱2,000.00;

SECTION 2. Consequent to the repeal of Ordinance No. 37, series of 1964, the excess of ₱1,800 in the City Mayor's Commutable Allowance is hereby reverted to the item on the Discretionary Fund of the City Mayor (Item No. 11) so that the said item is hereby amended to read as follows:

"Item No. 11 - Discretionary Fund (for Barrio Aid, salaries of Confidential Agents and Representation Expenses and Meal Allowances of the Municipal Board) ..... ₱ 21,800.00"
