RESOLUTION NO. 165

"WHEREAS, this august Body will remember having passed Resolution No. 94 on March 9, 1964, appropriating the sum of ₱400 from out of the unexpended balance in the 1963-1964 Ormoc City Budget to be made available as barrio aid to Sabang Bao for the completion of their shop building and construction of the school fence;

"WHEREAS, said appropriation could not be effected for reasons that the unexpended balance in the general fund is already depleted;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilor Tugonon;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 9

AN ORDINANCE REVERTING THE SUM OF FOUR HUNDRED PESOS FROM OUT OF THE PROVISION FOR FILING FEE TO RECOVER ORMOC WATERWORKS SYSTEM FROM NWSA, OFFICE OF THE CITY FISCAL, 1963-1964 ORMOC CITY BUDGET AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Four Hundred Pesos is hereby reverted from out of the provision for filing fee to recover Ormoc waterworks system from NWSA to be made available for appropriation as barrio aid to Sabang Bao for the purpose of finishing the construction of the shop building and the construction of the school fence thereof;

SECTION 2. This Ordinance shall take effect immediately upon approval.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Barrio Council of Sabang Bao, the City Fiscal, the City Treasurer and the City Auditor, all of Ormoc City;

"CARRIED. Six affirmative votes registered by Councilors Tugonon, Alfaro, Kierulf, Abas, Besabella and Du; Two negative votes registered by Councilors Aviles and Pongos."
