ORDINANCE NO. 9

AN ORDINANCE REVERTING THE SUM OF FOUR HUNDRED PESOS FROM OUT OF THE PROVISION FOR FILING FEE TO RECOVER ORMOC WATERWORKS SESTEM FRON NWSA, OFFICE OF THE CITY FISCAL, 1963-1964 ORMOC CITY BUDGET AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Four Hundred Pesos is hereby reverted from out of the provision for filing fee to recover Ormoc waterworks system from NWASA to be made available for appropriation as barrio aid to Sa-Thang Bao for the purpose of finishing the construction of the shop buildging and the construction of the school fence thereof;

SECTION 2. This Ordinance shall take effect immediately upon approval.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Barrio Council of Sabang Bao, the City Fiscal, the City Treasurer and the Lity Auditor, all of Ormoc City;
