## ORDINANCE NO. 1

AN ORDINANCE CREATING ANOTHER POSITION OF CITY MIDWIFE IN THE CITY HEALTH DEPARTMENT, PROVIDING COMPENSATION THEREOF AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The position of one more City Midwife is hereby created in the City Health Department with compensation at the rate of One Thousand Five Hundred Sixty Peses (Pl. 560.00) per annum.

SECTION 2. The sum of Seven Hundred Eighty Peses (P780.00) or se much thereof is hereby reverted from out of the salary savings accruing to the City Health Department, particularly, Item No. 17 (C-17), page 12, 1964-1965 Ormoc City Budget, to be made available for the salary of the new City Midwife covering the period from January 1 to June 30 1965, inclusive, at the rate of One Hundred Thirty Pesos (P130,CO) per month.

SECTION 3. The City Treasurer is hereby directed to make a supplemental budget to this effect.

SECTION 4. This Ordinance shall take effect as of January 1, 1965.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Regional Health Director and the Regional Director of the Civil Service Commission, both of Cebu City, the City Health Officer, the City Treasurer and the City Auditor, all of Ormoc City;
