ORDINANCE NO. 10

AN ORDINANCE REVERTING THE SUM OF EIGHTY PESOS (\$80) FROM ITEM NO. 32 AND THE SUM OF SIXTY PESOS AND FIFTY CENTAVOS (\$\mathbb{P}60.50) FROM ITEM NO. 30, BOTH UNDER THE OFMOC CITY INTERMEDIATE SCHOOL FUND (D-21), PAGE 16, 1964-1965 ORMOC CITY BUDGET, FOR SCHOOL GARDEN FENCING AND TRAVELING EXPENSES OF MR. AMADO ARCAYAN, ORMOC CITY CENTRAL SCHOOL, RESPECTIVELY

BE IT ORDAINED, by authority of the Municipal Board, of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Eighty Peses (P80) or so much thereof is hereby reverted from Item No. 32 under the Ormoc City Intermediate School Fund (D-21), page 16, 1964-1965 Ormoc City Budget, otherwise known as provision for repair of office equipment, to be made available for appropriation as aid to the City Central School for the panetting of the school garden.

SECTION 2. The sum of Sixty Pesos and Fifty Centaves (\$\overline{P}60.50) or so much thereof is hereby reverted from Item No. 30 under the Ormoc City Intermediate School Fund (D-21), page 16, 1964-1965 Ormoc City Budget, otherwise known as the provision for medical supplies and equipment, to made available for appropriation for the traveling expenses of Mr. Amade Arcayan also of the Ormoc City Central Schoel.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
