ORDINANCE NO. 11

AN ORDINANCE REVERTING THE SUM OF EIGHT HUNDRED PESSS (\$800.00) FROM OUT OF ITEM 14, C-16, PACE 11, 1964-1965 ORMOC CITY BUDGET FOR BARRIO AND SCHOOL AID TO MACABUG, ORMOC CITY

SECTION 1. The sum of Bight Hundred Pesos (\$800) or so much thereof is hereby reverted from out of Item No. 14, C-16, page 11 of the 1964-1965 Ormoc City Budget, otherwise known as provision for one fire truck, locally mounted, to be made available for appropriation as barrio and school aid to Macabug, Ormoc City, for repair and improvement purposes of the Macabug Community School building.
