ORDINANCE NO. 19 - Amended by Ordinance No. 20

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND PESOS (P1,000) FROM OUT OF ITEM NO. 38, C-15, POLICE DEPARTMENT, PAGE 10, 1964-1965 ORMOC CITY BUDGET FOR SCHOOL AID TO ORMOC CITY CENTRAL SCHOOL AS CONTRIBUTION TO LUNCHEON EXPENSES FOR OFFICIALS AND GUESTS OF THE DIVISION ATHLETIC MEET AND SCIENCE AND MATHEMATICS TEACHERS CONVENTION TENDERED BY HON. CONGRESSMAN DOMINADOR M. TAN OF THE FOURTH DISTRICT OF LEYTE

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of One Thousand Pesos (P1,000) or so much thereof is hereby reverted from out of Item No. 38, C-15, Police Department, page 10, Ormoc City Budget of 1964-1965, otherwise known as provision for one (1) police jeep, to be made available for appropriation as school aid to the Ormoc City Central School and/or contribution of the City Government for the luncheon in addition to the contribution of Honorable Dominador M. Tan, Congressman Dominador M. Tan of the Fourth District of Leyte, tendering said luncheon for officials and guest of the 1965 Division Athletic Meet and Science and Mathematics Teachers Convention in Ormoc City on January 28, 1965.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
