ORDINANCE NO. 20

AN ORDINANCE AMENDING ORDINANCE NO. 19, SERIES OF 1965, ENTITLED, "AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND PESOS (₱1,000) FROM OUT OF ITEM NO. 38, C-15, POLICE DEPARTMENT, PAGE 10, 1964-1965 ORMOC CITY BUDGET FOR SCHOOL AID TO ORMOC CITY CENTRAL SCHOOL AS CONTRIBUTION TO LUNCHEON EXPENSES FOR OFFICIALS AND GUESTS OF THE DIVISION ATHLETIC MEET AND SCIENCE AND MATHEMATICS TEACHERS CONVENTION TENDERED BY HON. CONGRESSMAN DOMINADOR M. TAN OF THE FOURTH DISTRICT OF LEYTE"

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Section 1 of Ordinance No. 19, series of 1965, is hereby amended to read as follows:

"SECTION 1. The sum of One Thousand Pesos (\$\mathbb{P}\,1,000) or so much thereof is hereby reverted from out of Item No. 32, C-5, Finance Department, ipage 7, 1964-1965 Ormoc City Budget, to the Commutable Allowance of the Honorable City Mayor to be made available for appropriation for school aid to the Ormoc City Central School as contribution of the City Government for the luncheon expenses in addition to the contribution of Congressman Dominador M. Tan of the Fourth District of Leyte tendering said luncheon for the officials and guests of the 1965 Division Meet and Mathematics and Schence Teachers Convention in Ormoc City on January 28, 1965.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
