## ORDINANCE NO. 21

AN ORDINANCE AMENDING ORDINANCE NO. 12, SERIES OF 1964, ENTITLED, "AN ORDINANCE AMENDING ORDINANCE NO. XIV, SERIES OF 1965, ENTITLED, 'AN ORDINANCE LEVYING AN ADDITIONAL TAX OF ONE CENTAVO PER LITER OF VOLUME CAPACITY OF GASOLINE SOLD WITHIN ORMOC CITY, AMENDING FOR THE PURPOSE PARAGRAPH (a), SECTION 2, ORDINANCE NO. 9, SERIES OF 1948, ENTITLED, "AN ORDINANCE FIXING LICENSE FEES FOR THE SALE OF GASOLINE, KEROSENE, PETROLEUM, OR CRUDE OIL AND PRESCRIBING RULES AND REGULATIONS THEREOF AND FOR OTHER PURPOSES"."

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Sub-paragraph (b), Section 2, Ordinance No. 12, series of 1964, is hereby amended to read as follows:

"(b) For every tin of petroleum, kerosene or its equivalent, Twelve Centavos (P0.12);"

SECTION 2. This Ordinance shall take effect immediately upon its approval. ENACTED, March 3, 1965.

"RESOLVED, FINALLY, to furnish a copy of this ordinance each to the Shell Company of the Philippines Limited, Cebu Branch, P.O. Box 142, Cebu City, the City Treasurer, the City Auditor, and all concerned, Ormoc City;
