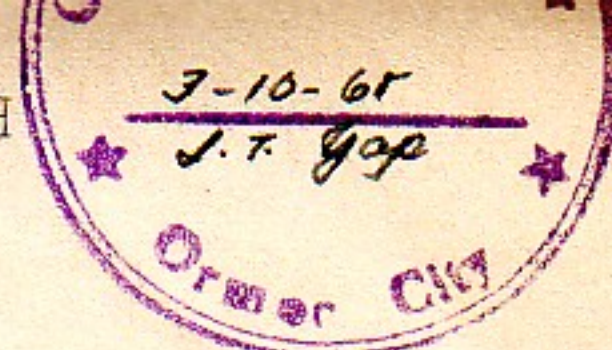


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE FIFTH

RESOLUTION NO. 38

"The Board, on motion of Councilor Abas, seconded by Floor Leader Tugonon and Councilor Kierulf;

"RESOLVED, to adopt:

ORDINANCE NO. 22

AN ORDINANCE REVERTING SALARY SAVINGS ACCRUING TO UNFILLED POSITIONS UNDER (C-1) OFFICE OF THE CITY MAYOR FOR THE PURCHASE OF TYPEWRITER, NEW WEBSTER'S INTERNATIONAL DICTIONARY, AND OTHER EQUIPMENT AND SUPPLIES IN THE SAME OFFICE

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of One Thousand Five Hundred Sixty Pesos ₱1,560) or so much thereof is hereby reverted from out of salary savings accruing to unfilled positions of one Agricultural Adviser and Fertilizer In Charge (Item No. 7) and one Messenger-Janitor (Item No. 8) in the Office of the City Mayor (C-1), 1964-1965 Ormoc City Budget, for the period from July 1, 1964, to January 31, 1965, and the period from July 1 to December 31, 1964, respectively, said sum to be made available for appropriation for the purchase of one Olympia typewriter, German made, one New Webster's International Dictionary and other equipment and supplies in the same office.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
