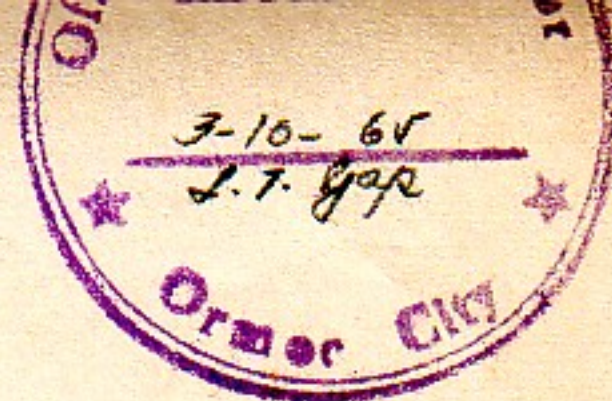

"The Board, on motion of Councilor-Floor Leader Tugonon, seconded by Councilor Du;

"RESOLVED, to adopt:

ORDINANCE NO. 23

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED FIFTY PESOS (P250) FROM OUT OF SALARY SAVINGS IN THE ORMOC CITY INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR THE REPAIR OF THE ROOFING OF THE SABANG BAO COMMUNITY SCHOOL BUILDING

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Two Hundred Fifty Pesos (P250) or so much thereof is hereby reverted from out of salary savings in the Ormoc City Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation for the repair of the roofing of the Sabang Bao Community School building.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, March 3, 1965.
