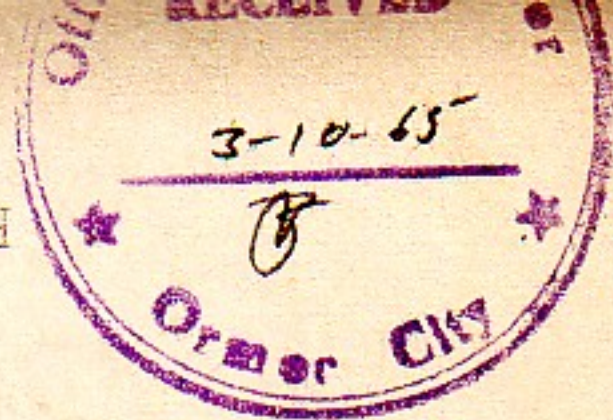

RESOLUTION NO. 44

"WHEREAS, Mr. Pastor Metran, Barrio Captain of Danao Lake, this City, has made representations with this august Body presenting Resolution No. 2 dated October 10, 1964, of the Barrio Council of Danao Lake requesting a barrio aid of P500 for the construction of an extension room for the Danao Lake Community School;

"NOW, THEREFORE, the Board, on motion of Floor Leader Tugonon, seconded by Councilors Kierulf and Besabella;

"RESOLVED, to adopt:

ORDINANCE NO. 24

AN ORDINANCE REVERTING FIVE HUNDRED PESOS (P500) FROM OUT OF SALARY SAVINGS IN THE CITY INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR BARRIO AID TO DANAOLAKE

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Five Hundred Pesos (P500) or so much thereof is hereby reverted from out of salary savings in the City Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation for barrio aid to Danao Lake for the construction of an extension room for the Danao Lake Community School.

SECTION 2. This Ordinance shall take effect immediately upon approval.

ENACTED, March 3, 1965.

"RESOLVED, FINALLY, to furnish a copy of this resolution-ordinance each to the Barrio Captain of Danao Lake, the City Treasurer and the City Auditor, all of Ormoc City;
